Overview

Located in the greater Omaha metropolitan area, Ameristar Casino Hotel Council Bluffs is one of Iowa's largest casinos. The property features a 38,500 square-foot casino, a AAA Four Diamond full-service hotel with 160 well-appointed rooms, five dining options, three bars, an entertainment venue; and 8,000 square-feet of meeting and event space.

Opened

The facility opened in January 1996.

Casino

The spacious casino consists of 38,500 square feet of gaming excitement, with a complete selection of popular slot and table games.

Offerings include:

- More than 1,500 slot machines, including reels, video reels, video poker and video keno
- More than 20 table games, including blackjack, craps and roulette

Members can relax in a private, richly appointed lounge while enjoying complimentary food and beverages and warm, personalized service from the Club 38 staff.

Hotel

All rooms feature luxury furnishings, high-definition LED televisions and in-room safes. Wireless high-speed Internet access is also offered. Each standard guest room has one king-sized or two queen-sized beds. All 40 suites include hot tubs. Non-smoking and wheelchair accessible rooms are available.

Convention and Meeting Facilities

With its 8,000 square feet of meeting space, Ameristar Council Bluff's Conference Center can accommodate events of all sizes. The Grand Ballroom contains 5,000 square feet of convention and meeting space with a 1,400-square-foot pre-function area; a 500-square-foot boardroom; and, in the Riverside Room, 1,100 square feet of meeting space.

Fitness and Pool Facilities

The fitness center includes a sauna and an indoor swimming pool with a glass wall that overlooks the Missouri River. Weather permitting; the wall opens to a sunbathing patio.

Dining

AMERISPORTS BAR is a great place to enjoy the big game while also savoring such house specials as beer-battered chicken tenders, sizzling beef, chicken fajitas and homemade giant pretzels. The restaurant and bar contain more than 35 television screens, including a multi-screen video wall and a real-time sports ticker.

BELLA'S BAKERY & CAFÉ offers generous portions of pure heartland goodness in a casual setting. The bakery features fresh cinnamon rolls and homemade cakes, pies, muffins and breads.

DOUBLE DOWN DOGS is the place to visit for a quick casual bite, located right on the casino floor.

HERITAGE BUFFET includes seven exhibition-style serving stations serving cuisines from all over the world (with great American cooking, too). The stations that feature interactive display cooking are action packed. Woks sizzle at the Asian station, while at its Italian counterpart, pasta boils in steaming pots. And, best of all, you can experience this exotic fare without straying far from home. The buffet seats up to 350 guests and includes a private room with audio/video capabilities.

RIVA STEAK & SEAFOOD Riva translates to "bank" or "shore" of the river and has gently wrapped its food offering philosophy around these roots. From the floating aroma of freshly baked breads to mouthwatering pan-seared, hardwood smoked salmon with creamy horseradish cabbage, Riva is sure to provide an experience you won't forget.

Entertainment

CENTER SPORTS BAR is the most prominent of the numerous bars at Ameristar Council Bluffs. Located on the casino's third floor, it features four plasma-screen televisions and 18 high-tech video poker and reel machines.

AMERISPORTS BAR offers great free live entertainment from local acts featured in this sports-themed outlet.

Shopping

The Merk & Tyler Gift Shop offers souvenir gifts, assorted sundries, beverages, snacks books and magazines.

Parking/Valet

Ameristar Council Bluffs features a covered 1,000-stall garage with access to the pavilion and the Ameristar II riverboat. Complimentary valet service also is available.

The Company also holds a majority interest in the racing license owner, as well as a management contract, for Retama Park Racetrack outside of San Antonio, Texas.

On March 29, 2016, the Company entered into a definitive agreement with a subsidiary of Gaming and Leisure Properties, Inc. to acquire the operations of The Meadows Racetrack and Casino for total consideration of \$138.0 million. The transaction is subject to the approvals of the Pennsylvania Gaming Control Board and Pennsylvania Harness Racing Commission, and other customary closing conditions. The transaction is expected to close by the end of the 2016 third quarter.
